विषयः-मध्यप्रदेश पर्यटन नीति 2010 (यथा संशोधित 2014) के तहत हेरिटेज होटल पर पूंजीगत अनुदान के संबंध में प्रकिया निर्धारण।

मध्यप्रदेश पर्यटन नीति 2010 (यथा संशोधित 2014) के तहत हैरिटेज होटल पर पूँजीगत अनुदान के संबंध में नीति कंडिका-7.2 निम्नानुसार वर्णित हैं

1. "निजी स्वामित्व वाले भवनों को यदि भवन स्वामी अथवा अन्य निवेशक द्वारा हेरिटेज होटल में परिवर्तित कर संचालित किया जाता है तो उसके द्वारा किये गए पूँजीगत व्यय का 35 प्रतिशत अनुदान (Subsidy) दिया जाएगा, जिसमें भूमि का मूल्य सिम्मिलित नहीं है।

पूंजीगत व्यय का 35 प्रतिशत अनुदान अथवा 1.50 करोड़ रूपए जो भी न्यूनतम हो, देय होगा, अर्थात् पूंजीगत व्यय पर अनुदान की अधिकतम सीमा 1.50 करोड़ रूपए होगी।

अनुदान का भुगतान तभी किया जायेगा जबिक निवेशक द्वारा होटल के निर्माण के पश्चात हेरिटेज होटल के रूप में संचालन का एक वर्ष पूर्ण कर लिया हो तथा होटल को HRACC (Hotel and Restaurants Approval and Classification Committee) द्वारा हेरिटेज होटल के रूप में वर्गीकृत कर दिया गया हो। पूँजीगत व्यय का आकलन राज्य पुरातत्व विभाग तथा पर्यटन निगम के अधिकारियों की एक समिति द्वारा किया जायेगा। समिति के प्रतिवेदन में उल्लेखित व्यय को ही अंतिम रूप से पूंजीगत व्यय मान्य किया जाएगा।

हेरिटेज सम्पत्ति के स्वामियों को पर्यटन विभाग द्वारा हेरिटेज पर्यटन के संबंध में तकनीकी मार्गदर्शन निःशुल्क उपलब्ध कराया जावेगा।

2. कंडिक में वर्णित हेरिटेज होटल से तात्पर्य है :"All those buildings, forts, havelis,

b) The architectural features of the building should be maintained in harmony with the original architectural design.

c) Immediate surroundings of the heritage hotels should be in consonance with the

architectural features of the original building

Front elevation, architectural style and general construction practice should exemplify local cultural traditions and features

Cuisine and catering services of the Heritage hotels should be clean, hygienic and of good standards and it should give the flavor and taste of local traditions, service,

facilities and immediate surroundings of high quality and standards.

Any extension, improvement, renovation, change in the existing structure should be in consonance with the traditional architectural styles and constructional techniques harmonizing the new with the old. After expansion/renovation the newly build up area added should not exceed 50% of the total built up (plinth) area including the old and new structures. For this purpose facilities such as swimming pool, lawns etc will be excluded"

- 3. उपरोक्त नीति के अंतर्गत निजी निवेशक द्वारा आवेदन पत्र (संलग्नक-1) वांछित दस्तावेजों के साथ प्रबंध संचालक, म.प्र. राज्य पर्यटन विकास निगम को प्रस्तुत किया जायेगा। संपूर्ण व्यवस्था ऑनलाईन होने पर समस्त आवेदन ऑनलाईन प्राप्त किये जावेंगे।
- 4. ऑनलाईन/ऑफलाईन प्राप्त आवेदनों पत्रों की जॉच प्रबंध् संचालक, म०प्र० राज्य पर्यटन विकास निगम द्वारा कराई जायेगी जिसमें पूंजीगत व्यय का आकलन राज्य पुरातत्व विभाग तथा पर्यटन निगम के अधिकारियों द्वारा संयुक्त रूप से किया जावेगा।
- 5. निजी निवेशकों द्वारा हेरिटेज के संचालन का एक वर्ष पूर्ण होने के उपरान्त पूंजीगत अनुदान की पात्रता होगी। अतः पूंजीगत अनुदान हेतु विधिवत आवेदन प्राप्त होने के अधिकतम 30 दिवस में पूंजीगत अनुदान प्रदाय किया जाएगा।
- 6. प्रभावशीलता का दिनांक:-ऐसी परियोजना जिसका संचालन पर्यटन नीति 2010 (यथा संशोधित 2014) के जारी होने के दिनांक 4 अक्टूबर 2014 के बाद प्रारम्भ हुआ हो।
- 7. इस प्रकार के पूंजीगत अनुदान, मांग संख्या-37, मुख्य शीर्ष 3452-पर्यटन, के अन्तर्गत योजना शीर्ष 1271-पूंजीगत अनुदान के अंतर्गत विकलनीय होगा। vpu
