1)	The tender is published for 25nos. 9.9HP 4 stroke OBM but in RFP it says 40 boats. Please clarify we as a bidder can only quote for 25nos. OBM and also it will be a complete amount with no breakup.	Please refer to Sl. no. 3 of corrigendum no. 1
2)	In RFP it says the bidder has to Install rigging, ignition, throttle & steering lines to new outboard motors as necessary, install new harnesses, wiring, gauges, fuel/water separating system(s), Lanyard shut off, control box and cables but in Technical-specification it says 9.9HP tiller operated rope Pull start OBM. Kindly clarify we have to quote Tiller/Manual Operated OBM or Remote/Steering operated model as the price difference between both the OBM is very high.	Please refer to point number 4.4 & 4.5 on pg. number 3 of RFP and Sl. no 2 of corrigendum no. 1
3)	Do we need to quote for the complete SITC of OBM & Modification or just SITC of 9.9HP OBM. As it is very difficult at this stage to anticipate the cost of modification of all 25 boats.	Please refer to Sl. no. 4 of corrigendum no. 1
4)	GST- Do we need to quote the Prices including GST or you will pay the GST amount extra. Kindly clarify	Please refer to point number 13.2 on pg. number 5 of RFP
5)	Payment Terms: We request you to make the payment in a lot of minimum 5 units after Installation, Testing & Commissioning as we the transom modification of 20nos. boats may consume a lot of time.	Please refer to updated payment terms in corrigendum no. 1 Sl. no. 5
6)	Warranty: Please clarify what all will be covered in comprehensive warranty such as cost of consumable spares & Accidental damages cannot be anticipated at this stage. We request you to amend it such that the repair cost will not be charged by us but the consumable spares cost & Accidental damage cost will be paid by the boat owner on case-to-case basis.	Warranty as per company norm, please refer to Sl. no. 5 of corrigendum no. 1
