(i)	2.2.5	<p>Point no 2.2.5 has been revised as under:</p> <p>The bidder must have successfully completed at least three events / festivals along with manage and operate minimum 50 tents, in the field of Tourism for Central Government / State Government with a project cost of minimum Rs. 3 Crores during the 5 7 years preceding the proposal due date. Copies of the Work Order / Completion Certificate need to be submitted.</p>
(ii)	3.2	<p>Point no 3.2 (1) has been revised as under:</p> <p>The bidder must have successfully completed at least three events / Festivals <u>along with manage and operate minimum 50 tents</u>, in the field of Tourism for Central Government / State Government with a project cost of minimum Rs. 3 Crores during the 5 7 years preceding the proposal due date</p> <p>Minimum 3 Festivals - 5 Marks</p> <p>Above 3 Festivals - 3 Marks for Each Festival Up to 20 Marks</p> <p>The value of the work should be more than Rs 3 Crores.</p> <p>Note: Work order or Completion certificate need to be enclosed</p>
(iii)	1.3.22 (K)	<p>Point no 1.3.22 (K) has been added as under:</p> <p>Any sponsorship sought for the event should have prior approval of the Authority. Decision of the Authority in this regard shall be final.</p>
(iv)	1.3.8 page 11	<p>Point no 1.3.8 has been revised as under:</p> <p>Land Agency is expected to do recce and find the land for erecting tent city as well as organizing Floating Festival. Agency shall obtain all the approvals for land and MPTB will facilitates to agency to get the approval. In case of private land agency is expected to negotiate the rent with landlord pay accordingly and inform to MPTB.</p> <p>Note- Land for organizing Festival shall be provided by MPTB. However the agency is free to undertake an independent recce and find any other land deemed suitable for erecting tent city as well as organizing the festival. The Agency shall be required to obtain all the necessary approvals for the land so identified by the Agency, MPTB shall facilitates the Agency in getting the approval. In case of such land identified by the Agency, the Agency is also expected to negotiate the rent with landlord, pay accordingly and inform to MPTB.</p>
